This Dealer "Credit Service" Agreement (this "Agreement") is made effective as of this date of _____, 2012. This agreement is between, Credit Repair Today, LLC (hereafter known as CRT), and the Dealer,

1. In consideration of the mutual promises contained herein and other good and valuable consideration of **\$2800.00** for the initial set-up of the dealer's private and secured Credit Service client monitoring database. CRT also agrees to add at the dealer's discretion separate department databases at no extra charge.
2. CRT will provide a log-in portal for the clients of the dealership in the "Credit Service" program, to be installed on the dealer's company website.
3. CRT will be responsible for the hosting and maintenance of all websites and data-bases created and provided to the above named dealer.
4. CRT will initiate set-up of the Credit Service department, train all personnel involved, and supply all necessary forms for client enrollment that comply with Attorney General's Office and Federal Trade Commission Guidelines.
5. CRT will be responsible for the collection of all client fees and will thereby compensate above named dealer as described in the Dealer Compensation Schedule.
6. CRT will be responsible for the credit restoration processing of all "Credit Restoration" clients and maintain all processing requirements as they pertain to the clients that remain enrolled in the CRT "Credit Restoration" program.
7. CRT will monitor clients enrolled into the program for a period of 90 days at no extra charge. After that, dealer may assume this responsibility or pay us a monthly monitoring fee of \$300.
8. Either party may cancel this agreement at any time.

Dealer Compensation Schedule

- 1) CRT agrees to pay the above named dealer \$100 for each Individual Client credit restoration enrollment and \$150 for each Couple enrollment from above mentioned dealer. CRT will pay the full amount of \$100/\$150 when CRT receives payment in full for the credit restoration process and \$50/\$75 for two (2) monthly payments which are when the 1st and 3rd payments are made by the client. Dealer will only be paid their fee when:
 - A) Client's payment clears bank from a check or merchant account from a Debit/Credit Card.
 - B) Client makes scheduled payments to CRT.
- 2) Dealer will be compensated on the 1st of the month from client enrollment from the 1st thru the 15th of the previous month, and on the 15th of the month from client enrollment from the 16th thru the end of the previous month.
